

## M.D.C. Holdings Reports Selected Preliminary 2019 Fourth Quarter Results

DENVER, Jan. 6, 2020 /[PRNewswire](#)/ -- M.D.C. Holdings, Inc. (NYSE: MDC), one of the nation's leading homebuilders, reported selected preliminary results for the 2019 fourth quarter. These results are preliminary and unaudited.

### 2019 Fourth Quarter Highlights and Comparisons to 2018 Fourth Quarter (preliminary and unaudited)

- New home deliveries increased 31% to 2,389 from 1,827
  - Average sales price of approximately \$450,000
- Net new home orders increased 49% to 1,574 from 1,059
  - Monthly sales absorption pace increased 28% to 2.8
- Homes in backlog increased 29% to 3,801 from 2,936
  - Dollar value of backlog increased 23% to \$1.75 billion

As previously announced, MDC will release its 2019 fourth quarter earnings before the market opens on Thursday, January 30, 2020. MDC will host a teleconference the same day at 12:30 pm ET.
